Terms and conditions for e-auction:


1. The above said articles/items will be disposed of through e Auction (NIC Portal).
2. All the participants will have to upload the following documents on the e-auction portal and have to submit the same in the Institute office on or before 28.04.2025 by 5:00 p.m. failing which they will not be allowed to participate in the auction:
 - a. Security deposit of Rs. 2000/- payable in favour of the Director State Council of Educational Research and Training, Sector-32, UT Chandigarh in the shape of Banker cheque/Demand Draft before start of the e-auction process.
 - b. Copy of GST No.




3. All the unserviceable items/articles will be sold as a single lot and no bid would be accepted for any part of the same.
4. The reserve price of the materials is fixed at Rs. 9,200/- and any bid offered less than this amount will not be considered.
5. The security deposit will be returned/refunded to the bidders within 2 months after successful award of the bid to the highest bidder. No interest shall be paid.
6. Highest bidder should deposit 25% of the bid price immediately on the same day.
7. Period for payment of balance amount will be 3 days from the award of contract.
8. The amount of 25% of bid price paid shall be forfeited if the balance amount is not paid within the 3 days.
9. The goods will be handed over to the successful bidder only after receiving the balance amount (i.e. Highest bid amount minus 25 % partial amount deposit). In case the selected bidder does not show interest in depositing the balance amount the entire amount shall be forfeited and other actions initiated including resale of the goods in questions at the risk and cost of defaulter.
10. The items shall remain, in every aspect, at the risk of the buyer from the time of acceptance of his offer. The seller will not undertake any liability whatsoever for the safe custody, protection or preservation after the sale has been confirmed.
